### Zoom Meetings:

- Lindy asked if we could set up Zoom for Members that cannot attend in person to allow them to participate.
- Chief and Jason Feagin will work on this as an option.

## Chief's Report:

- Administration Assistant
  - Beth Pitts gave her 2-weeks' notice
  - Made a tentative offer to Renay, who will start training with Beth.
- Completed the Wildland Protection Plan with CCME
  - $\circ$   $\;$  They have a board now just for their wildland community efforts.
- Mitigation project in Lakemore is about halfway done, should be completed by summer.
- Approved permit modifications for the development going in down by Cripple Creek. They should get their permits in the coming weeks to start breaking ground.
- Got to use some of the modifications we made to Brush 32. Got to use the new winch during the ice storm.
- Chief thanked Captain Benavidez for pulling him out when he was stuck.
  - Chief got a good ribbing for being from Texas and not knowing how to drive in the snow.
- Teller County Dispatch Supervisor asked for Chief and NETCO's Fire Chief to help write the SOPs for the new radios.

- Several of the fire signs for subdivision will be going up in next month.
- Call volume is still increasing, especially since we are tracking more than we used too.
  - $\circ$   $\;$  Prior to Chief they were reporting 40-50 calls since the 1st of the year.
  - We are already at 126 for the year.
  - These figures are very helpful when we start applying for more grants.
- We officially transfer to Dr. Hurtado on April 1<sup>st</sup>.
- BLS Intercept will also be going live in April.

## Captain Lopez EMS Report:

- Met with Centura Reps regarding the switch to Dr. Hurtado on 4/01. Sending over guidelines as well.
- New Guidelines coming down just a few minor changes, one such change are less medications required in stock.
- Just placed our large restocking order about \$800
- 1<sup>st</sup> grant hearing last week, will be one more hearing. This is for CPR dummies and monitors.

## Captain Pitts Report:

- E-88 is down again, will have to dig in and see what is going on with it this time.
- All other apparatus are up and running.
- Snow chains are all laid out by the apparatus.
- This summer we need to buy some repair links to fix the snow chains, so they fit properly.
- Will be utilizing milk crates to store the chains and mark which apparatus each crate goes to. Will help keep them organized.
- Minor issue with R-31, steps aren't deploying.

## Shop Foreman's Randy Bruggink Report:

• Randy Bruggink made a motion that we pay Anthony for his time plowing at the stations, \$50 each station and retroactive. 2<sup>nd</sup> by Steve Witcher. No further discussion, approved

- B-32 is back up and running. We are just waiting for a few small parts to come in for the minor repairs left.
- The S130-L190 Class is coming up, as are the Wildland Trainings.
