# **Chief's Report:**

- We had three subdivision's fire signs were ordered last week and will be working on getting those installed.
  - Two other subdivisions working on fund raising for their signs still.
  - CCME has ordered signs and is working on ordering more signs since they have multiple options for egress.
  - o Working with Highland Meadows and Ranch resorts on getting their signs.
  - o Hoping that by end of summer all the subdivisions will have fire signs.
- Fire Authority update
  - Don Angell is meeting with Florissant Fires board tonight
  - o It is not looking like anything will happen with the Fire Authority though.
- Trainings:
  - o Captain Benavidez mentioned the joint training we did with Tallahassee Fire.
  - We also did some training with Guffey Fire at the Gorge.
  - Helicopter training was cancelled due to weather, have another training scheduled for Saturday.
- Guffey is getting a new Fire Chief, Chief has already started working with the new chief.
  - o Current Chief at Guffey will be stepping down at the end of the year.
- County is putting together a Fire Academy, hoping for the end of May.
  - Should be able to get some Four Mile Fire Fighters certified.
- We have 6 new BLS CPR folks certified as of last Saturday's CPR class.
- We have made several orders in the last month, and some of it has already come in.
  - Phasing out a lot of our expired PPE and not up to standards.

- Captain Benavidez and Jay did SCBA inventory, and we are in really good at least for a few more years.
- We have training coming on a barn structure that a resident is allowing us to burn.
  - Try to make it a three-day training. First two days will be burning, third day will be the fire investigators training.
  - o Two state fire investigators coming up to do some training on the burn.
  - Third Day we will burn it to the ground.
  - o Couple of other departments interested in attending as well.
- Ordered some new radios. we have few people that needed new radios.
- Transition to the 800mhz radios
  - We have been trying to figure out how to obtain all of the new radios we need.
  - CDOT has purchased new equipment and the county has acquired 100 of those radios,
  - o Four Mile is getting 1<sup>st</sup> pick and we will be getting about 25 new radios at no cost.
  - Tori posed questions on how we need to book these radios, and if we need to track them as assets.
  - It is not a donation it is reacquisition, and we will need to track them as assets since they are worth about \$20,000.
- Last week was Chief Bauer's last week as President of Chiefs Council.
  - Jay is now the president of the Chiefs council.
- Interviewed a new recruit today. Young gentleman up near Cripple Creek will be joining the department.
- RMOU with Dr. Hurtado
  - Final draft was done this week. Jay and Captain Lopez have reviewed.
  - Sent back with an amendment and will hopefully have back tomorrow to finalize the transition to Centura.
  - We are no longer operating under Dr. DeWall and are fully under Dr. Hurtado.
  - Will all be official once Jay has signed the agreement.
- Thank you to Steve and Tori for all they have been doing with receipts and tallying everything
  up.
  - o Tori has been taking on the Verizon account for the Department as well.
- Question posed regarding new guidelines for Dr. Hurtado:
  - Don Angell is paying for the new EMS guidelines from Dr. Hurtado. We had already paid for the ones Dr. Dewall put out that are now no good.
- Question posed regarding BLS Intercept beginning April 1:
  - o That is still on hold, Dr. Hurtado has left it up to us when to start.
  - Current hold up is the Ambulance inspection, once that is done we will likely start doing intercept.
- Getting some requests to start Transport up from outlying departments.
  - Working on the legalities and liabilities of doing this now.
- Update on Mutual Aide Agreement with Stone Mountain for Wildfires.
  - We have some issues they need to address before an agreement is put in place.
  - A lot of legal stuff left to work out.

## **Captain Lopez EMS Report:**

- Randy and Anthony fixed the headlight on the Ambulance. Thank you both!
- Captain Benavidez led his 1st CPR training class last Saturday. Did a great job!
- Will be holding another CPR class on a weekday in the near future.
- Ordered and received about \$900 in supplies for the ambulance. Working a few more thing we need and will be fully stocked.
- John Mason is trying to see if we can get our required drugs from Penrose Pharmacy, or another pharmacy for a better price. John is working with Dr. Hurtado on this.
- New EMT David Quick on the roster. David works for Southwest Teller and has been approved to join us by Dr. Hurtado.

# **Captain Pitts Report:**

- E31 is down again, had it up and running for a few days. Moved it to station 2 and it started overheating. Working on figuring that out.
- B32 is all emissions stuff that needs fixed. Working to make it run better and more reliable.
- All other apparatus is up and operational.
