EXHIBIT A TO ELECTION RESOLUTION

SHALL FOUR MILE FIRE PROTECTION DISTRICT TAXES BE INCREASED \$185,000 ANNUALLY, OR BY SUCH AMOUNT AS MAY BE RAISED BY THE IMPOSITION OF AN ADDITIONAL MILL LEVY RATE OF UP TO 4.7 MILLS, THE REVENUE THEREFROM TO PAY FOR THE DISTRICT'S GENERAL OPERATIONS, INCLUDING FIRE PROTECTION, EMERGENCY MEDICAL AND RESCUE SERVICES, AND FOR CAPITAL EXPENSES, SUBJECT TO ADJUSTMENT ANNUALLY TO OFFSET REVENUE LOSSES FROM REFUNDS, ABATEMENTS AND CHANGES IN LAW REGARDING, OR THE METHODS OF CALCULATING, THE RATIO OF VALUATION FOR ASSESSMENT; AND SHALL FOUR MILE FIRE PROTECTION DISTRICT BE AUTHORIZED TO COLLECT, RETAIN AND SPEND THE PROCEEDS OF SUCH TOTAL MILL LEVY RATE AS A VOTER-APPROVED REVENUE CHANGE, OFFSET AND EXCEPTION TO THE LIMITS WHICH WOULD OTHERWISE APPLY UNDER TABOR (ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION) OR ANY OTHER LAW AND AS A PERMANENT WAIVER OF THE 5.5% LIMITATION UNDER SECTION 29-1-301, C.R.S.?
